- The Braintree Town Hall is accessible to persons with disabilities. Enter the building from the ramp on the north side of the building (toward Central Avenue).
- Accessible by transit (complete transit and highway directions on reverse):
  - o MBTA bus Route 230. Northbound bus: Quincy Center Station via Braintree Station; Washington St. & Gilbert Dean Dr. stop. Southbound bus: Montello via Braintree Station; Washington St. opp. Washington Park Rd. stop.
  - o MBTA Red Line; Braintree Station.
  - o Kingston/Plymouth and Middleborough/Lakeville commuter rail lines; Braintree Station.

The MPO is scheduled to hear a presentation from Braintree officials on transportation issues in Braintree and the South Shore Coalition subregion. Members will discuss and take action on a proposed scope of work for an upcoming planning study. There will also be presentations on and discussions of performance-based planning at the MPO and recent evaluations of projects proposed for the region's Transportation Improvement Program (TIP).

Upon request (preferably two weeks in advance of the meeting), every effort will be made to provide accommodations such as assistive listening devices, materials in accessible formats and in languages other than English, and interpreters in American Sign Language and other languages. # DIRECTIONS TO BRAINTREE TOWN HALL

Braintree's Town Hall is located at 1 J.F.K. Memorial Drive near the intersection of Union Street and Washington Street across from Thayer Public Library.

## BY CAR

**From the North (I-93 N from Boston):** Take I-93 S toward Quincy. Take exit 7 on the left toward Cape Cod / Route 3 South. Take exit 17 for Union St toward Braintree/South Braintree. At the traffic circle, take the 1st exit onto Union St. Turn left onto Washington St. Take the 2nd right (very close) onto John F. Kennedy Memorial Drive. (Town Hall is across Washington Street from Thayer Public Library – 798 Washington St.)

**From the West (I-93 N / Route 1 from Randolph):** Take I-93 N toward Quincy. Take exit 7 toward Cape Cod / Route 3 South. Take exit 17 for Union St toward Braintree/South Braintree. At the traffic circle, take the 1st exit onto Union St. Turn left onto Washington St. Take the 2nd right (very close) onto John F. Kennedy Memorial Drive. (Town Hall is across Washington Street from Thayer Public Library – 798 Washington St.)

**From Route 3 and Points East:** Take exit 17 for Union St toward Braintree/South Braintree. At traffic circle, take 3rd exit onto Union St. Turn left onto Washington St. Take the 2nd right (very close) onto John F. Kennedy Memorial Dr. Destination is on the left. (Town Hall is across Washington Street from Thayer Public Library – 798 Washington St.)

**From Holbrook and Points South:** Head North on Washington St / Route 37. Continue straight on Hancock St where Route 37 turns left as Washington St. Continue straight onto Washington St as Hancock St becomes Washington St. Continue 0.2 miles and turn left onto John F. Kennedy Memorial Dr. Destination will be on the left. (Town Hall is across Washington Street from Thayer Public Library – 798 Washington St.)

## PARKING

Car parking is available in the Town Hall parking lot. Bicycle racks are available in front of the building.

## BY PUBLIC TRANSPORTATION

### MBTA Red Line

Get off at Braintree Station. See below for walking directions.

### MBTA Commuter Rail

- Middleborough/Lakeville Commuter Rail Line –
  - Inbound train (Train # 010) on Middleborough/Lakeville Line: Arrives at 8:44 a.m.
- Kingston/Plymouth Commuter Rail Line –
  - Inbound train (Train # 040) on Kingston/Plymouth Line: Arrives at 9:14 a.m.
  - Outbound train (Train # 061) on Kingston/Plymouth Line: Arrives at 9:15 a.m.
- Get off at Braintree Station. See below for walking directions.

### Walking from Braintree Station (5-10 minute walk)

Exit station and follow walkway to Union St  
Turn left on Union St  
Walk approximately 2 blocks west on Union St  
Turn left on Washington St  
Walk approximately 2 blocks south on Washington St

**MBTA Bus Route** – Service on bus Route 230 is available. Northbound – Quincy Center Station Via Braintree Station (Washington St. & Gilbert Bean Dr.). Southbound – Montello Via Braintree Station (Washington St. opposite Washington Park Rd.).
