The **FFY 2021 Federal Obligation Report** lists the transportation projects from MassDOT, the Massachusetts Bay Transportation Authority, the MetroWest Regional Transit Authority, and the Cape Ann Transportation Authority within the Boston Region MPO area on which federal funds were expended during FFY 2021 (October 1, 2020– September 30, 2021).
